PROJECT INSTRUCTIONS & SAFETY REQUIREMENTS

GENERAL PROCEDURES:

- Absolutely no open-toed shoes or flip flops!
- An adult must accompany volunteers 13 years old and younger
- Must wear gloves and vests or event t-shirts provided by KRCB staff
- Stay in open areas and use the buddy system
- Work in small groups and take direction from your team leader
- Never let other volunteers go off alone
- Stay alert at all times
- Keep away from cars and traffic
- Tools are not toys
- Do not enter construction zone.

LITTER CLEANUP TIPS:

- Keep trash bags at 20lbs.
- Do not drag trash bags, pick them up
- Double tie all trash bags
- Please dispose of trash bags in your own personal trash bin
- Any objects that may pose a threat should be left untouched. Notify your team leader.
 Examples: toxic or hazardous waste, syringes, weapons,
 - Examples: toxic or hazardous waste, syringes, weapons, chemicals, broken bottles or objects

PERSONAL HEALTH:

- Bring any necessary medication with you
- Do not overwork yourself & stay hydrated
- For medical emergency, dial **9-1-1**

BULKY ITEMS: Be cautious!

- Be careful handling bulky items such as: tires, woods and auto parts, if heavy ask for assistance if needed
- Palm fronds should be flattened and piled under trash bags to prevent them from blowing away
- Move bulky items to a designated place, take a photo and send it to KRCB

ANIMAL CARE:

- If an animal poses a threat, or you find a dead animal, do not touch them
- Call the Dept. of Animal Services: 951-358-7387

GRAFFITI

- Remove small graffiti tags with the graffiti wipe provided in your *supply bag*
- Notify your Team Leader of large graffiti tags and use your phone to call **311** or access the **311 app** to report it

FIRST+AID/COVID -19 GUIDELINES:

- Masking requirements will follow CDC, CDPH, and Cal/OSHA guidelines at time of event
- Keep appropriate distance when working as a team
